DEVELOPMENT OF WEBSITE BY PRE-SHIPMENT INSPECTION AGENTS (PIAs) FOR EASE OF NON-OIL EXPORT OPERATIONS

The government-appointed Pre-shipment Inspection Agents (PIAs) for non-oil exports, namely - **Messrs. Cobalt International Services Limited, Neroli Technologies Limited and Carmine Assayer Limited** under the Nigerian Export Supervision Scheme (NESS), have established functional websites to facilitate non-oil export trade in the South-West, South-South/South-East and Northern Geo-political Zones assigned to them, respectively.
